- Provide a copy of your ICBC driving record (available at https://onlinebusiness.icbc.com/clio/)
- Complete a police information check (must be on file with ERS and current—expires after 3 years; you will need to go to the Sicamous RCMP detachment with the attached letter police checks will take one week on average for results and you will need to return back to the detachment to get your completed form).
